1. Background

In 2001, Section 508 of the Rehabilitation Act of 1998 was passed, requiring all Federal government agencies, as well as any organization that receives Federal funding, to comply with this law. In order for these agencies and organizations to disseminate information over the Internet to persons with disabilities, it is crucial that they follow the guidelines of Section 508. Universal web access becomes more important with each day, as Internet usage continues to surge even among persons with disabilities. It is not only socially responsible for organizations to make their websites accessible to this population, but as Section 508 proves, it is the law for many agencies and organizations.

2. Description of Evaluation

This website accessibility evaluation was conducted by reviewing the City of Pasadena Cultural Affairs Division Webpage <http://www.ci.pasadena.ca.us/arts/homecult.asp>. A review of the expansion of text size, disabling of Javascript and CSS, validation of HTML, CSS, and Section 508 was conducted using a Web Developer Add-On on Firefox. A deuteranope simulation was conducted by running a Visicheck, through the website Visicheck.com <http://www.visicheck.com/visicheck/visicheckURL.php>.

3. Accessibility Evaluation Results

The website passed the majority of the accessibility evaluation tests; however, it failed the W3C Validation Tests for HTML and Cascading Style Sheets (CSS).

4. Detailed Evaluation Criteria

a. **Expand Size of Text**

The website passes this test, as it remains legible when the text size is increased by three settings.

b. Turn Off Javascript and Check Navigation

The website passes this test, as the website navigation does not change when Javascript is disabled.

c. Turn of CSS and Confirm the Structure of the Page

The website passes this evaluation. When CSS styles are disabled, the page structure remains intact.

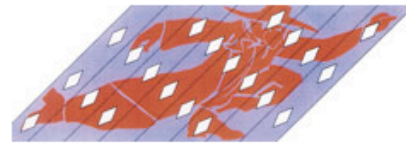
The website passes testing for Deuteranope simulation (a form of red/green color deficit). The website was still usable and navigable for users with this vision deficit.

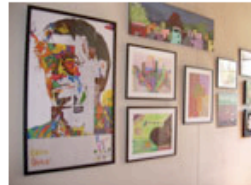

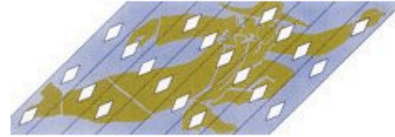

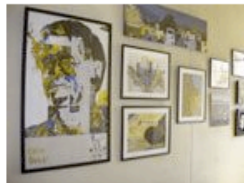
